STATEMENT BY THE HEAD OF DELEGATION OF BOTSWANA AT THE 99TH COUNCIL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION (IOM)

29TH NOVEMBER 2010 GENEVA, SWITZERLAND

Mr. Chairman,

Director General,
