1. In a letter dated 31 March 2011, the Republic of Maldives applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 15 April 2011, are annexed.
2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Maldives for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0011 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted to the Council for consideration.

It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council.

**LETTER DATED 15 APRIL 2011 FROM THE DIRECTOR GENERAL OF

A document formally presenting your Government's application for membership will be distributed to all Member States. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
