## APPLICATION BY THE REPUBLIC OF NAURU FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter received on 23 June 2011, the Republic of Nauru applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 29 June 2011, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Nauru for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0011 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

# LETTER RECEIVED ON 23 JUNE 2011 FROM THE MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF NAURU TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
