1. In a letter received on 23 June 2011, the Republic of Nauru applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 29 June 2011, are annexed.
2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Nauru for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0011 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted to the Council for consideration.

**LETTER RECEIVED ON 23 JUNE 2011 FROM THE  
MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF NAURU

Sir,

I have the honour to refer to the relationship existing between the Government of the Republic of Nauru and the International Organization for Migration (IOM).

My Government wishes to establish a closer relationship with your Organization and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of the Republic of Nauru accepts the Constitution, and the amendments thereto of 24 November 1998, in accordance with its constitutional processes and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and Nauru.

A document formally presenting your Government's application for membership will be distributed to all Member States. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
