1. In a letter dated 16 November 2011, the Republic of Seychelles applied for membership in the International Organization for Migration. The letter and the Director General's reply, dated 21 November 2011, are reproduced in the annexes to this document.
2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Seychelles for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0022 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted to the Council for consideration.

**LETTER DATED 16 NOVEMBER 2011 FROM THE MINISTER FOR
FOREIGN AFFAIRS OF THE REPUBLIC OF SEYCHELLES
TO THE DIRECTOR GENERAL OF
THE INTERNATIONAL ORGANIZATION FOR MIGRATION**

Sir,

I have the honour to refer to the exchanges that have taken place in the last year between the Government of Seychelles and the International Organization for Migration (IOM).

As the Government wishes to establish a closer relationship with the International Organization for Migration, we are hereby applying for Seychelles membership to the organization in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of Seychelles accepts the Constitution, and the amendments thereto of 24 November 1998, in accordance with its constitutional processes and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and Seychelles.

A document formally presenting your Government's application for membership will be distributed to all Member States. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
