APPLICATION BY THE REPUBLIC OF CAPE VERDE
FOR MEMBERSHIP IN THE ORGANIZATION

1. In a letter dated 30 July 2001, the Republic of Cape Verde applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 9 February 2001, are annexed.
2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Cape Verde for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.040 per cent of the total contributions required from Member States to the Administrative part of the Budget.
3. An appropriate draft resolution will be submitted for consideration by the Council.

LETTER DATED 30 JULY 2001 FROM THE SECRETARY OF STATE
FOR FOREIGN AFFAIRS OF THE REPUBLIC OF CAPE VERDE
ADDRESSED TO THE DIRECTOR GENERAL OF THE
INTERNATIONAL ORGANIZATION FOR MIGRATION

Sir,

I have the honour to refer to the relationship existing between the Government of the Republic of Cape Verde and the International Organization for Migration (IOM). My Government wishes to establish a closer relationship with your Organization and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

As indicated in the attached “Letters from the Republic of Cape Verde for adhesion to the Constitution of the International Organization for Migration (IOM)” signed by the President of the Republic, the Government of the Republic of Cape Verde accepts the Constitution in accordance with its constitutional processes and the obligations resulting from membership. It undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Republic of Cape Verde.

LETTER DATED 3 AUGUST 2001 FROM THE DIRECTOR GENERAL
OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO
THE SECRETARY OF STATE FOR FOREIGN AFFAIRS OF
THE REPUBLIC OF CAPE VERDE

Sir,

I have the honour to acknowledge receipt of your letter dated 30 July 2001, in which you inform us that the Republic of Cape Verde wishes to become a member of the International Organization for Migration (IOM), in accordance with Article 2, paragraph (b), of the Constitution.

I note that your Government accepts the Constitution in accordance with its constitutional processes and the obligations resulting from membership, and that it undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of Cape Verde.

I am confident that your Government's action will be received with satisfaction by the Member States of IOM. At the same time, I should like to express our deep gratification at this further strengthening of the already close and cordial relationship between the Republic of Cape Verde and IOM.

I am pleased to confirm that the necessary steps will be taken to place your Government's application for membership on the agenda of the next session of the IOM Council, to be held in Geneva at a date which will be communicated shortly.

A document formally presenting your Government's application for membership will be distributed to all Member States and observers. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
