**ADMISSION OF MEXICO
AS A MEMBER OF THE ORGANIZATION**

The Council,

Having received the request of Mexico for admission as a Member of the Organization (MC/2062),

Having been informed that Mexico accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

Considering that Mexico has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

Convinced that Mexico could give valuable assistance towards furthering the purposes of the Organization,

Resolves:

1. That Mexico be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative part of the Budget be determined at 1.237 per cent thereof.

**ADMISSION OF IRELAND
AS A MEMBER OF THE ORGANIZATION**

The Council,

Having received the request of Ireland for admission as a Member of the Organization (MC/2066),

Having been informed that Ireland accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

Considering that Ireland has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

Convinced that Ireland could give valuable assistance towards furthering the purposes of the Organization,

Resolves:

1. That Ireland be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative part of the Budget be determined at 0.335 per cent thereof.
