**ADMISSION OF MONGOLIA  
AS A MEMBER OF THE ORGANIZATION**

*The Council,*

*Having received* the request of Mongolia for admission as a Member of the Organization (MC/2243),

*Having been informed* that Mongolia accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

*Considering* that Mongolia has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

*Convinced* that Mongolia could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That Mongolia be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;
2. That its contribution to the Administrative Part of the Budget be determined at 0.026 per cent thereof.

*Convinced* that the Republic of India could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That the Republic of India be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;
2. That its contribution to the Administrative Part of the Budget be determined at 0.483 per cent thereof.

*The Council,*

*Empowers* the Chairperson of the Ninety-fifth (Special) Session of the Council, Mr. J. Garrigues, to sign on behalf of the Organization the contract thus approved, pursuant to Article 18 of the Constitution.
