1. In a letter dated 7 November 2012, Saint Vincent and the Grenadines applied for membership in the International Organization for Migration. The letter and the Director General's reply, dated 13 November 2012, are reproduced in the annexes to this document.
2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of Saint Vincent and the Grenadines for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0011 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted to the Council for consideration.

**LETTER DATED 7 NOVEMBER 2012 FROM
THE PRIME MINISTER OF SAINT VINCENT AND THE GRENADINES
TO THE DIRECTOR GENERAL OF
THE INTERNATIONAL ORGANIZATION FOR MIGRATION**

Sir,

I have the honour to refer to the relationship existing between the Government of St. Vincent and the Grenadines and the International Organisation for Migration (IOM).

My Government wishes to establish a closer relationship with your Organisation and hereby applies for membership in the International Organisation for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of St. Vincent and the Grenadines accepts the Constitution, and the amendments thereto of November 24, 1998, in accordance with its constitutional processes and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organisation, the rate of which will be agreed upon by the IOM Council and St. Vincent and the Grenadines.

**LETTER DATED 13 NOVEMBER 2012 FROM THE DIRECTOR GENERAL OF
THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO
THE PRIME MINISTER OF SAINT VINCENT AND THE GRENADINES**

I have the honour to acknowledge receipt of your letter of 7 November 2012 in which you inform me that the Government of Saint Vincent and the Grenadines wishes to become a Member of the International Organization for Migration (IOM), in accordance with Article 2, paragraph (b), of the IOM Constitution.

I note that your Government accepts the Constitution of IOM, and the amendments thereto of 24 November 1998, in accordance with its constitutional processes, as well as the obligations resulting from membership, and that it undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and Saint Vincent and the Grenadines.

I am confident that your Government's application will be received with satisfaction by the Member States of IOM and would like to express my deep gratification at this further strengthening of the already close and cordial relationship between Saint Vincent and the Grenadines and IOM.

I take pleasure in informing you that the 101st Session of the Council, at which your Government's application will be submitted to the Member States of IOM for approval, will be held in Geneva from 27 to 30 November 2012.

A document formally presenting your Government's application for membership will be distributed to all Member States. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
