# APPLICATION BY THE WORLD FOOD PROGRAMME FOR REPRESENTATION BY AN OBSERVER

- 1. In a letter dated 18 September 2012, a copy of which is appended as Annex I, the Executive Director of the World Food Programme (WFP) made a formal application for her Organization to be accorded observer status at meetings of the IOM Council. The Director General's reply thereto, dated 12 October 2012, is appended as Annex II. An appropriate item will be included on the provisional agenda of the 101st Session of the Council.
- 2. This matter falls under rule 10 of the Rules of Procedure for the Council which provides that the Council may admit, upon their application, international organizations, governmental and non-governmental, concerned with migration, refugees or human resources as observers at its meetings.
- 3. An appropriate draft resolution will be submitted to the Council when this matter comes up for decision.

### LETTER DATED 18 SEPTEMBER 2012 FROM THE EXECUTIVE DIRECTOR OF THE WORLD FOOD PROGRAMME TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

# LETTER DATED 12 OCTOBER 2012 FROM THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO THE EXECUTIVE DIRECTOR OF THE WORLD FOOD PROGRAMME

I have the honour to refer to your letter of 18 September 2012 in which you convey the desire of the World Food Programme (WFP) to be granted observer status with the International Organization for Migration (IOM).
