### APPLICATION BY THE REPUBLIC OF THE UNION OF MYANMAR FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 21 November 2012, the Republic of the Union of Myanmar applied for membership in the International Organization for Migration. The letter and the Director General's reply, dated 23 November 2012, are reproduced in the annexes to this document.
- 2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of the Union of Myanmar for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0065 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

# LETTER DATED 21 NOVEMBER 2012 FROM THE MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF THE UNION OF MYANMAR TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

I have the honour to refer to the relationship existing between the Government of the Republic of the Union of Myanmar and the International Organization for Migration (IOM).

My Government wishes to establish a closer relationship with your Organization and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of the Republic of the Union of Myanmar accepts the Constitution, and the amendments thereto of 24 November 1998, in accordance with its constitutional processes and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of the Union of Myanmar.

# LETTER DATED 23 NOVEMBER 2012 FROM THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO THE MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF THE UNION OF MYANMAR
