### APPLICATION BY THE REPUBLIC OF MALAWI FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 15 May 2013, the Republic of Malawi applied for membership in the International Organization for Migration. A copy of the letter and the Director General's reply, dated 27 May 2013, are reproduced in the annexes to this document.
- 2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Malawi for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0011 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

#### LETTER DATED 15 MAY 2013 FROM THE MINISTER OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF THE REPUBLIC OF MALAWI TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

Sir,

I have the honour to refer to the relationship existing between the Government of the Republic of Malawi and the International Organisation for Migration (IOM).

My Government wishes to establish a closer relationship with your organization and hereby applies for membership in the International Organisation for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of the Republic of Malawi accepts the Constitution, and the amendments thereto of 24 November, 1998, in accordance with its constitutional process and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organisation, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of Malawi.

# LETTER DATED 27 MAY 2013 FROM THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO THE MINISTER OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF THE REPUBLIC OF MALAWI
