APPLICATION BY THE REPUBLIC OF CHAD FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 31 March 2011, the Republic of Chad applied for membership in the International Organization for Migration. This letter and the Director General's reply, dated 11 April 2011, are reproduced in the annexes to this document.
- 2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Chad for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0022 per cent of the total contributions that Member States are required to make to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

LETTER DATED 31 MARCH 2011 FROM THE MINISTER OF FOREIGN AFFAIRS, AFRICAN INTEGRATION AND INTERNATIONAL COOPERATION OF THE REPUBLIC OF CHAD TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of Chad.
