## APPLICATION BY THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 31 March 2011, the Federal Democratic Republic of Ethiopia applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 14 April 2011, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Federal Democratic Republic of Ethiopia for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0087 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

# LETTER DATED 31 MARCH 2011 FROM THE DEPUTY PRIME MINISTER AND MINISTER OF FOREIGN AFFAIRS OF THE FEDERAL DEMOCRATIC REPUBLIC OF ETHIOPIA TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government.
