## APPLICATION BY THE SOUTHERN AFRICAN DEVELOPMENT COMMUNITY SECRETARIAT (SADC) FOR REPRESENTATION BY AN OBSERVER

- 1. In a letter dated 7 April 2011, a copy of which is appended as Annex I, the Executive Secretary of the Southern African Development Community Secretariat (SADC) made a formal application for his Organization to be accorded observer status at meetings of the IOM Council. The Director General's reply thereto, dated 12 May 2011, is appended as Annex II. An appropriate item will be included on the provisional agenda of the Hundredth Session of the Council.
- 2. This matter falls under rule 10 of the Rules of Procedure for the Council which provides that the Council may admit, upon their application, international organizations, governmental and non-governmental, concerned with migration, refugees or human resources as observers at its meetings.
- 3. An appropriate draft resolution will be submitted to the Council when this matter comes up for decision.

# LETTER DATED7 APRIL 2011 FROM THE EXECUTIVE SECRETARY OF THE SOUTHERN AFRICAN DEVELOPMENT COMMUNITY SECRETARIAT (SADC) TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION

Sir,

I have the honour to refer to the contacts established between the International Organization for Migration and the SADC Secretariat when we met in the margins of the African Union Summit in Addis Ababa, and your recent follow-up communication regarding migration issues of mutual interest to both our Organisations. The IOM's programmes and activities in the field of migration are of great interest to SADC and we wish to establish a closer relationship with your Organisation.

It will be recalled that currently, the SADC/IOM collaboration is guided by the existing Memorandum of Understanding signed between the two organizations in 2004, in Gaborone, Botswana. As the SADC Region continues to progress towards deeper integration, migration challenges relating to migrant labour, HIV and AIDS and mobile population, trafficking in women and children, and the need to link SADC's diasporas to national and regional development priorities, are becoming even more apparent and must be effectively addressed. There is therefore, a compelling demand for increased collaboration in the area of migration and mobile populations which should include developing a comprehensive regional migration policy framework for SADC.

I am pleased to inform you that the SADC Secretariat desires to take part in the work of the International Organization for Migration and I shall appreciate your taking the necessary steps to submit this request to the next Session of the IOM Council for consideration.

In the meantime, the Secretariat will continue liaising with Mr. Bernardo Mariano, the IOM Regional Representative for Southern Africa to discuss further collaboration on migration issues including renewal of the existing MoU, development of a regional migration policy framework and secondment of staff for technical assistance to support SADC on migration and related issues.
