# APPLICATION BY THE SOUTHEAST EUROPEAN COOPERATIVE INITIATIVE (SECI) – REGIONAL CENTER FOR COMBATING TRANSBORDER CRIME FOR REPRESENTATION BY AN OBSERVER

- 1. In a letter dated 12 November 2001, ref. SCS 6765, a copy of which is appended as Annex I, the Director of the Southeast European Cooperative Initiative (SECI) Regional Center for Combating Transborder Crime made a formal application for his organization to be accorded observer status at meetings of the IOM Council. The Director General's reply thereto, dated 21 March 2002, is appended as Annex II. An appropriate item will be included on the provisional agenda of the Eighty-third (Special) Session of the Council.
- 2. This matter falls under rule 10 of the Rules of Procedure for the Council which provides that the Council may admit, upon their application, international organizations, governmental or non-governmental, concerned with migration, refugees or human resources as observers at its meetings.
- 3. If the Council so decides, the Southeast European Cooperative Initiative (SECI) Regional Center for Combating Transborder Crime will be included among the international non-governmental organizations listed in paragraph 2 (c) of Resolution No. 753 (LVIII).
- 4. An appropriate draft resolution will be submitted to the Council when this matter comes up for decision.
