## APPLICATION BY THE ISLAMIC REPUBLIC OF MAURITANIA FOR REPRESENTATION BY AN OBSERVER

- 1. In a letter dated 16 May 2002, a copy of which is appended as Annex I, the Permanent Representative of the Islamic Republic of Mauritania to the United Nations Office and international organizations in Geneva made a formal application for his country to be accorded observer status at meetings of the IOM Council. The Administration's reply thereto, dated 17 May 2002, is appended as Annex II. An appropriate item will be included in the provisional agenda for the Council's Eighty-third (Special) Session.
- 2. This matter falls under Rule 10 of the Rules of Procedure for the Council, which provides that the Council may admit, upon their application, non-member States as observers at its meetings.
- 3. If the Council so decides, the Islamic Republic of Mauritania will be included among the non-member States listed in paragraph 1 of Resolution No. 753 (LVIII).
- 4. An appropriate draft resolution will be submitted to the Council when this matter comes up for decision.
