- 1. In a letter dated 15 November 2002, the Republic of Zimbabwe applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 18 November 2002, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Zimbabwe for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.040 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted for consideration by the Council.

A document formally presenting your Government's application for membership will be distributed to all Member States and observers. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
