RESOLUTION No. 1080 (LXXXV)

(Adopted by the Council at its 447th meeting on 13 June 2003)

**ADMISSION OF THE ISLAMIC REPUBLIC OF MAURITANIA  
AS A MEMBER OF THE ORGANIZATION**

*The Council,*

*Having received* the request of the Islamic Republic of Mauritania for admission as a Member of the Organization (MC/2100),

*Having been informed* that the Islamic Republic of Mauritania accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

*Considering* that the Islamic Republic of Mauritania has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

*Convinced* that the Islamic Republic of Mauritania could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That the Islamic Republic of Mauritania be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative part of the Budget be determined at 0.040 per cent thereof.

**ADMISSION OF NEW ZEALAND  
AS A MEMBER OF THE ORGANIZATION**

*The Council,*

*Having been informed* that New Zealand accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

*Considering* that New Zealand has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

*Convinced* that New Zealand could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That New Zealand be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative part of the Budget be determined at 0.270 per cent thereof.

1. That Moldova be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative part of the Budget be determined at 0.040 per cent thereof.

**ELECTION OF A DIRECTOR GENERAL**

*The Council,*

*Bearing in mind* the terms of Article 18 of the Constitution,

*Resolves* to re-elect Mr. Brunson McKinley as Director General, in accordance with Article 18 of the Constitution, for five years as from 1 October 2003.
