## APPLICATION BY THE REPUBLIC OF MALTA FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 15 October 2003, the Republic of Malta applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 30 October 2003, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Malta for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.040 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted for consideration by the Council.

# LETTER DATED 15 OCTOBER 2003 FROM THE MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF MALTA ADDRESSED TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
