- 1. In a letter dated 29 March 2004, the Republic of the Niger applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 30 March 2004, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of the Niger for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0,040 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted for consideration by the Council.
