#### ADMISSION OF THE SOCIALIST PEOPLE'S LIBYAN ARAB JAMAHIRIYA AS A MEMBER OF THE ORGANIZATION

The Council,

*Having received* the request of the Socialist People's Libyan Arab Jamahiriya for admission as a Member of the Organization (MC/2129),

Having been informed that the Socialist People's Libyan Arab Jamahiriya accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

Considering that the Socialist People's Libyan Arab Jamahiriya has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution.

*Convinced* that the Socialist People's Libyan Arab Jamahiriya could give valuable assistance towards furthering the purposes of the Organization,

#### Resolves:

- 1. That the Socialist People's Libyan Arab Jamahiriya be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;
- 2. That its contribution to the Administrative Part of the Budget be determined at 0.075 per cent thereof.

- 1. That Afghanistan be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;
- 2. That its contribution to the Administrative Part of the Budget be determined at 0.040 per cent thereof.
