**ADMISSION OF THE REPUBLIC OF MAURITIUS
AS A MEMBER OF THE ORGANIZATION**

The Council,

Having received the request of the Republic of Mauritius for admission as a Member of the Organization (MC/2189),

Having been informed that the Republic of Mauritius accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

Considering that the Republic of Mauritius has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

Convinced that the Republic of Mauritius could give valuable assistance towards furthering the purposes of the Organization,

Resolves:

1. That the Republic of Mauritius be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative Part of the Budget be determined at 0.035 per cent thereof.

**ADMISSION OF THE KINGDOM OF SPAIN
AS A MEMBER OF THE ORGANIZATION**

The Council,

Having received the request of the Kingdom of Spain for admission as a Member of the Organization (MC/2193 and MC/2193/Add.1),

Having been informed that the Kingdom of Spain accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

Considering that the Kingdom of Spain has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

Convinced that the Kingdom of Spain could give valuable assistance towards furthering the purposes of the Organization,

Resolves:

1. That the Kingdom of Spain be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative Part of the Budget be determined at 2.755 per cent thereof.
