## APPLICATION BY THE SOMALI REPUBLIC FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 29 May 2008, the Somali Republic applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 2 June 2008, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Somali Republic for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.026 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

# LETTER DATED 29 MAY 2008 FROM THE MINISTER FOR FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF THE SOMALI REPUBLIC TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
