RESOLUTION No. 1180 (XCVII)

(Adopted by the Council at its 498th meeting on 29 June 2009)

**ADMISSION OF THE REPUBLIC OF TRINIDAD AND TOBAGO  
AS A MEMBER OF THE ORGANIZATION**

*The Council,*

*Having received* the request of the Republic of Trinidad and Tobago for admission as a Member of the Organization (MC/2269),

*Having been informed* that the Republic of Trinidad and Tobago accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

*Considering* that the Republic of Trinidad and Tobago has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

*Convinced* that the Republic of Trinidad and Tobago could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That the Republic of Trinidad and Tobago be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative Part of the Budget be determined at 0.029 per cent thereof.

**ADMISSION OF THE REPUBLIC OF NAMIBIA  
AS A MEMBER OF THE ORGANIZATION**

*The Council,*

*Having received* the request of the Republic of Namibia for admission as a Member of the Organization (MC/2270),

*Having been informed* that the Republic of Namibia accepts the Constitution of the Organization in accordance with its internal constitutional processes and has undertaken to make a financial contribution to the administrative requirements of the Organization,

*Considering* that the Republic of Namibia has demonstrated its interest in the principle of the free movement of persons as stated in Article 2 (b) of the Constitution,

*Convinced* that the Republic of Namibia could give valuable assistance towards furthering the purposes of the Organization,

*Resolves:*

1. That the Republic of Namibia be admitted as a Member of the International Organization for Migration, in accordance with the provisions of Article 2 (b) of the Constitution, as from the date of the present resolution;

2. That its contribution to the Administrative Part of the Budget be determined at 0.0064 per cent thereof.

**DEPARTURE OF THE DEPUTY DIRECTOR GENERAL**

*The Council,*

*Recalling* its Resolution No. 1101 (LXXXVII) of 4 June 2004 whereby it re-elected Mrs. Ndioro Ndiaye as Deputy Director General of the Organization for a second term of five years as from 1 September 2004,

*Having taken note* that the term of office of Mrs. Ndiaye comes to an end on 31 August 2009,

*Expresses* its sincere gratitude to Mrs. Ndiaye for her devotion to the interests of the Organization and for the able services she has rendered to the Organization and to the cause of migrants, refugees and displaced persons throughout the world in her capacity as Deputy Director General;

*Notes* with particular appreciation the accomplishments of Mrs. Ndiaye in strengthening the gender office; in promoting migration for development programmes; and in encouraging cooperation on South-South migration; and

*Expresses* its best wishes to Mrs. Ndiaye in her future endeavours.

*Resolves* to elect Ms. Laura Thompson Chacón as Deputy Director General, in accordance with Article 18 of the Constitution, for five years as from 1 September 2009.
