## APPLICATION BY THE KINGDOM OF SWAZILAND FOR MEMBERSHIP IN THE ORGANIZATION

- 1. In a letter dated 15 November 2010, the Kingdom of Swaziland applied for membership in the International Organization for Migration. A copy of the letter and of the Director General's reply, dated 17 November 2010, are annexed.
- 2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Kingdom of Swaziland for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0033 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
- 3. An appropriate draft resolution will be submitted to the Council for consideration.

#### LETTER DATED 15 NOVEMBER 2010 FROM THE MINISTER OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION OF THE KINGDOM OF SWAZILAND TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
