**Mr Chairperson,**

The combination of consequences caused by the terrorist armed groups in northern Mozambique and cyclical natural disasters in the country such as cyclones, floods and droughts emerging from climate changes, became a great cause for an increasing number of forced displacements in Mozambique. Therefore, my delegation calls to the international community for the need to build resilience through prevention, risk reduction, adaption and sustainable mechanisms.

We take this opportunity to thank IOM for its commendable work in Mozambique which contribute to build resilience for the displaced populations and local communities exposed to multiples vulnerabilities. We express our sincere appreciation to the IOM staff in Mozambique for their tireless work on the ground.

To conclude, **Mr Chairperson**, let me assure you that the Mozambique Government is committed to working with IOM as a lead UN agency on migration and with all members of the international community to strengthen our cooperation and for the achievement of the Global Compact for Migration goals and other commitments to ensure social and economic integration of migrants.
