STATEMENT By Francis NGANTCHA Minister Counsellor at the Cameroon Permanent Mission to the United Nations Office in Geneva

Before

The 90th Session of the Council of the International Organisation for Migration

On the occasion of the admission of the Republic of Cameroon as member Of IOM.

29 November 2005

Mr. President

Mr. Director General of the International Organisation for Migration

Mme Deputy Director – General

Excellencies, Distinguished delegates, Ladies and gentlemen.

Today is a great day for Cameroon. On the occasion of the accession of my country to this distinguish Organisation, it is with a renewed sense of respect, responsibility and reverence that I speak before this Council.

The IOM is today universally respected and acclaimed as the leading international intergovernmental and particularly humanitarian organisation concern with migration.

Mr. President,

We have been reminded in many circumstances that globalisation is irreversible. If we consider that globalisation and migration are two sides of the same coin, then we would not be wrong to assert that migration is irreversible in our present world. Globalisation and migration with a humane and in a structured process benefits both the international society and of course individuals or migrants concerned.

Mr. President,

It is with reverence that I look at the podium and identify the Director General and of course the Deputy Director General of this Organisation. The ceremony of today would not have happened but for the untiring efforts of these two personalities to welcome Cameroon as soon as possible. Thanks particularly to the visit in March 2005 of the Deputy Director General during which she met the Prime Minister of my country that I can say crystallized the desire of Cameroon to become a full member of this Organisation.

Cameroon stands ready to make her modest contribution to the objectives of this organisation and is very enthusiastic to became a full member, if so decided.
