Global Facts

68.5 million: Global forced displacement/conflict

41.3 million (62%): IDPs/conflict

Newly displaced in 2018

28 million

- Conflict: 10.8m

- Disaster: 17.2m

Many returnees face displacement-like conditions or are displaced a second time.

Vulnerable populations: more likely to be displaced by climate change impacts and remain displaced for longer

IOM AND THE MOBILITY DIMENSIONS OF CRISIS

30 million beneficiaries | **100** countries



BANGLADESH (ROHINGYA)

- Sector lead: site management, shelter, displacement tracking
- Medical consultations: 600,000 ppl
- WASH, shelter and household items: 600,000 ppl
- Engineering works, relocations and site development in 18 camps
- 3-year risk reduction strategy



Northeast NIGERIA

- 8 deep-field Humanitarian Hubs
 - 1 base camp
- Humanitarian assistance and relief (CCCM, WASH, NFI)
- CCCM services: 725,925 displaced persons | 142 camp/camp-like settings
- Biometrical registration: 444,000 individuals
- Mental health and psychosocial support: 596,000 individuals
- Disarmament Demobilization and Reintegration



MOZAMBIQUE

- Quick scale-up
- Coordination: Shelter NFI, CCCM, Core pipeline
- Shelter materials and other items: 250,000 persons
- Site management: 28,000 IDPs
- Displacement tracking: 65,000 IDPs
 - Humanitarian response
 - Durable solutions, incl. relocation



SYRIAN ARAB REPUBLIC & NEIGHBOURING COUNTRIES

- **Inside Syria lead**
 - IDP and return tracking
 - NFI/shelter and CCCM response in North West Syria
 - Inter-agency PSEA programme
- **Neighbouring countries**
 - Health, psychosocial and protection: 1 million refugees
 - Cash-based interventions: 150,000 refugees
 - Livelihood and community stabilization: 80,000 refugees
 - Transportation assistance: 35,000 refugees



YEMEN

Despite constrained supply chains, key areas of operation:

- Migrant assistance, DTM, food security, WASH, Health, Shelter/NFI, CCCM, Emergency employment and community rehabilitation
- Water sites rehabilitation: 700,000 beneficiaries
- 79 health facilities
- Voluntary Humanitarian Return: 1,000 vulnerable migrants



EBOLA OUTBREAK

Response: Democratic Republic of the Congo

- 82 Points of Entry and control
- 61million screenings of travelers
- 11 confirmed EVD cases identified and referred

Preparedness: Enhance Government capacity for surveillance and prevention

- Burundi, Rwanda, South Sudan, Tanzania, Uganda



TRANSITION AND RECOVERY

- Transition, recovery and stabilization: **43** countries
- Root causes: **28** countries
- DDR: **10** Countries
- Preventing violent extremism: **19** countries
- Durable solutions: **18** countries
- Disaster Risk Reduction: **48** countries
- Expertise and capacity-building on land, property and reparations



RESETTLEMENT AND MOVEMENT OPERATIONS

Resettlement and humanitarian admissions: 95,000

- Europe: 34,455
- United States of America: 28,289
- Canada: 23,694
- Australia: 7,371
- Others: 1,183

Humanitarian evacuation cell:

- 16,457 migrants from Libya to 35 countries of origin
- 3,278 migrants from Yemen to 10 destinations



COORDINATED RESPONSE PLATFORMS

- Regional Migrant Response Plan for the Horn of Africa and Yemen
- Migrant and Refugee Platform – Libya
- Regional Inter-Agency Platform - Venezuela
 - Regional Refugee and Migrant Response Plan - Venezuela



MIGRATION EMERGENCY FUNDING MECHANISM

- Established by Resolution No. 1229 (2011)
- Stopgap (loan) between immediate response and receipt of donor funding
- Voluntary contributions
- Intended balance **USD 30 million**.
- Critical low: USD 2.9 million



Proven pillar of IOM rapid response: at risk
