PROVISIONAL WORKPLAN FOR THE IOM GOVERNING BODIES DURING 2024

Provisional workplan for 2024

1. In 2021, Member States, through the Working Group on IOM Partnerships, Governance and Organizational Priorities, suggested that, in order to increase efficiency and enable Member States to better prepare for IOM governing bodies sessions, the Administration should provide an annual overview of the items to be considered by the Standing Committee on Programmes and Finance and the Council for the coming year.
2. As a result, in September of each year, the Administration prepares an overview of the regular agenda items of the Standing Committee and the Council that will be covered during the following year, as well as related decisions to be taken. The overview for 2024 is presented in the Annex to this document.
3. Additionally, should Member States wish the Administration to present information on a particular subject, they may make the request when this document is discussed by the Standing Committee, or at any other point.
4. In addition to the regular items on the agendas of both the Standing Committee and Council, in 2024, a special session of the Council will be held during the first half of the year to enable the Director General to inform Member States of her selections for the positions of Deputy Director General for Operations and Deputy Director General for Management and Reform. Moreover, during the 115th Session of the Council, an election will be held to appoint the External Auditor for the years 2025, 2026 and 2027.
