PROPOSED ADJUSTMENT TO THE IOM ASSESSMENT SCALE FOR 2025

1. Through its Resolution No. 1408 of 27 November 2023, the Council authorized the Standing Committee on Programmes and Finance, during 2024, to adopt a scale of assessment for the year 2025, on the basis of an IOM assessment scale fully equated to that of the United Nations, as set forth in document SCPF/4 and updated with the addition of new Member States.

Main principles and guidelines

2. Since 2009, the IOM assessment scale has been fully equated to the scale of the United Nations through the application of an equation factor, which equates the smaller number of IOM Member States to the larger United Nations membership.

3. The United Nations General Assembly adopted the assessment scale for 2022, 2023 and 2024 through resolution 76/238 of 24 December 2021, reaffirming the fundamental principle that the scale is established according to capacity to pay.

4. Owing to the timing of the issuance of the United Nations assessment scale, there is a one-year time lag in the application of the new scale in IOM. The United Nations scale for 2024 is therefore applied in IOM in 2025.

Proposed IOM assessment scale for 2025

5. As decided by the Council:

- (a) The 2025 assessment scale is fully equated to the United Nations assessment scale.
- (b) There has been no change in the IOM membership since the adoption of the 2024 assessment scale. Consequently, the proposed assessment scale for 2025 is the same as that approved for 2024.

Recommendations

6. It is proposed that:

- (a) The assessment scale for the Administrative Part of the Budget for 2025, as shown in the annex (column 3) to this document, be adopted;
- (b) The Standing Committee review the matter of the assessment scale for 2026 during 2025.
