



1. OIO Reform

- Consolidated Oversight: Investigation, Audit and Evaluation
- Decentralization: Establishment of 4 offices in
 - Bangkok,
 - Nairobi,
 - Panama City, and
 - Vienna.
- Increased resources: from 39 to currently 54 positions
- > 18 Positions vacant and under recruitment



2. Investigations – Caseload and Trends

- ➤ 45% increase of new allegations received: 2,803 (vs. 1,931)
- Significant increase in open cases: 1505 (vs. 617)
- > 1306 open matters at intake stage.
- > Trend is expected to continue with 341 new allegations received in Sept.





3. Audit Activities - Engagements and Findings

- OIO performed 16 engagements including 12 country office and 4 advisory audits.
- Of the 12 country office audits
 - 9 were: partially effective, with some improvements needed
 - 3 partially effective, with major improvements needed
- Recurrent findings are consistent with previous years and relate to:
 - Supply chain management
 - Finance to manage
 - Hire to retire
 - Plan to report
 - Risk management
 - Fundraising to agreement



3. Audit Activities – Status of Recommendations

- ➤ All 298 audit recommendations are "current", with no long outstanding recommendations
- Implementation of the recommendations is being closely monitored with their respective owners.

4. Evaluations

- ➤ In February 2024, Central Evaluations Division (CED) integrated into OIO
- > CED activities include:
 - Publication of Evaluation Strategy 2024-2028
 - Publication of six Central Evaluations
 - Guidance and technical support to decentralized evaluations
 - Support to Inter-Agency Humanitarian Evaluation initiatives
 - Development of web-based Monitoring & Evaluation guidelines
 - Publication of Real-Time Learning and Performance Monitoring Review Guidance
