#### **OPERATIONAL CONTEXT**

- Unprecedented levels of migration and displacement.
- Expanded operations and contact.
- Projectized organization with fragmented narratives on protection that resulted in incoherent, inconsistent and unpredictable responses.
- Requests and funding from member states to enhance protection, and to engage better with traditional protection actors, mandated agencies (UNHCR, OHCHR, ILO).



## EXPANDED REACH IN PROTECTION ASSISTANCE



#### **OPERATIONAL HIGLIGHTS: 2023**

- **Humanitarian action**: 2.69 million individuals assisted, a (32% increase from 2022)
  - Child protection: 172,324 reached in 45 countries (40% increase)
- Migrants in vulnerable situations: 146,036 reached with
  - 8,460 victims of trafficking (12% increase)
  - Unaccompanied or separated children: 9,211 (up 8%)
- Return and Reintegration assistance (AVRR and VHR): 71,951 migrants - 17% children
- Missing Migrants: Over 8,600 deaths/ disappearances globally (15% increase from 2022)



#### **DEMYSTIFYING THE APPROACH**

#### **What It Is Not:**

- No creation or expansion of mandate.
- No overlap with UNHCR's mandate, the focus is exclusively on populations outside of the asylum/refugee regime.




#### **IOM'S APPROACH TO PROTECTION**

#### **DEMYSTIFYING THE APPROACH**

#### What it is:

- Restatement of the IASC protection definition and response to the IASC Protection Policy Review.
- Reemphasizes IOM's duty to protect as defined in its Constitution.
- Reiterates IOM's goal on protection; it explains IOM's responsibility; describes protection in action; explains how IOM delivers on its protection commitments; details thematic areas of intervention; and reinforces partnership.








#### **DEMYSTIFYING THE APPROACH**

#### What it is:

- Consolidates IOM's approach covering specialized, integrated and mainstreamed protection areas and prompted the release of the Six-Pillar Framework for IOM's specialized protection work.
- Enhances accountability and ensures protection is delivered consistently, coherently and predictably.
- Primarily for staff but also for those we serve, partners and Member States.
