Provisional workplan for 2025

- 1. In 2021, Member States, through the Working Group on IOM Partnerships, Governance and Organizational Priorities, suggested that, in order to increase efficiency and enable Member States to better prepare for IOM governing bodies sessions, the Administration should provide an annual overview of the items to be considered by the Standing Committee on Programmes and Finance and the Council for the coming year.
- 2. As a result, in September of each year, the Administration prepares an overview of the regular agenda items of the Standing Committee and the Council that will be covered during the following year, as well as related decisions to be taken. The overview for 2025 is presented in the Annex to this document.
- 3. Additionally, should Member States wish the Administration to present information on a particular subject, they may make the request when this document is discussed by the Standing Committee, or at any other point.
