# LETTER DATED 25 APRIL 2013 FROM THE VICE PRESIDENT, GLOBAL STRATEGIES, OF THE INTERNATIONAL MEDICAL CORPS TO THE DIRECTOR GENERAL OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
